Banking house Lampe advises investors to buy CeWe Color shares. The medium-term target price was raised from 33.60 to 34.50 euros. On Friday the share price was at 26.50 euros. The company conducts its business in the photographic sector. Operations were improved in the first quarterly period and targets for the full year, which appear to be realistic, were re-confirmed. With expected sales unchanged, sales of photo books, which generate higher margins, are likely to rise.
